Dear Parents and Carers,

Please read the following information carefully. The Digital Safety at Stapleford Community Primary School booklet is for you to keep but please return the attached Parent/Carer and Visitor Digital Device Agreement on the next page.

Digital technology including the use of computers/laptops/tablets for the internet, e-mail and other technologies has become an important part of learning in our school. We expect all pupils to be safe and responsible when using any digital technology. Our school system requires your child to have an individual email address and therefore at home and school they are able to access and edit their work no matter what type of digital device they are using provided it has access to the internet. We have set as many perimeters to ensure your children stay safe online but we would encourage you to keep discussing your children's internet use with them.

One of the main messages is the analogy that you wouldn't expect to hear your child say 'I'm going out' and give you no further information, you would want to know where they were going and who with. This is the same approach we encourage on digital devices, ask your children what websites they are going on, and if they are using it for communication with other people, who the people are that they are communicating with.

We would like to take the opportunity to make you aware your child will never be permitted to bring in or use their own digital technology in school unless under special circumstances in which you and your child will meet with the Computing Leader or Headteacher to discuss and agree prior to permission being given.
