Equality Statement

As outlined in the Equality Act 2010 schools have a duty to publish a statement which covers the general and specific duties outlined in the act.

General and specific duties: The Act covers all aspects of a school's work and establishes nine strands or 'protected characteristics' related to:

- · Age (not in terms of school pupils or prospective pupils)
- · Disability
- · Ethnicity and race
- ·Gender
- · Gender identity and transgender
- · Marriage and civil partnership
- · Pregnancy, maternity and breastfeeding
- · Religion and belief
- · Sexual identity and orientation

The general duty (also known as the public sector equality duty - PSED) requires all schools – including other state-funded educational settings and academies – to have due regard to the need to:

a) eliminate discrimination, harassment, victimisation and any other conduct that is prohibited by or under this Act

b) advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it

c) foster good relations between persons who share a relevant protected characteristic and persons who do not share it.

At **Stapleford Community Primary School** we will be focusing on the Protected Characteristics. The use of unacceptable language towards minority groups and those with disabilities and

prejudice-related incidents are dealt with very seriously. We are committed to ensuring equality of education and opportunity for all pupils, staff, parents and carers, irrespective of race, gender, disability, belief, religion or socio-economic background.

Equality Objectives. In order to further support pupils, raise standards and ensure inclusive teaching, we have set the following objectives:

- To foster positive relations across protected characteristics
